**Memorandum of Understanding  
Between  
LSi Business School  
and  
Universidade Católica Timorese**

This Memorandum of Understanding (MOU) sets forth the terms and understandings between LSi Business School (LSi) and Universidade Católica Timorese (UCT) São João Paulo II to collaborate in the development and implementation of student scholarships, student/faculty exchange, short-term learning events, and research.

**Background**

LSi is the only business school in Cambodia to focus exclusively on Small and Medium Enterprise (SME) management. With its motto, "Entrepreneurship, Innovation, Humanity," LSi seeks to produce graduates who are knowledgeable and experienced in business management, have a creative mindset, and are socially responsible global citizens. LSi offers English language programs, a Bachelor of Business Administration in SME Management, and an Executive Master of Business Administration (EMBA) in SME Leadership.

UCT opened in December 2021 and has a student body of almost 1,000, the majority of whom are studying business. They are in the process of building their teaching and research resources, including through collaborative ventures with other universities.

**Purpose**

✓ This MOU will serve to establish the partners' mutual interest in collaborating on activities including, but not limited to:

- Five full tuition scholarships for instructors to the EMBA program
- Additional 50% tuition scholarships for UCT faculty, staff, their children, and students to BBA or EMBA program
- Student-faculty exchanges, including internship placements.
- Joint research

**Reporting**

Monitoring and evaluation of this MOU will be carried out by the Dean of the International Relations Office of LSi and the Rector's Office of UCT.

**Funding**

LSi commits to offer five seats, at a 100% tuition scholarship, for UCT instructors to study in the EMBA program. In addition, LSi will provide 50% tuition scholarships to faculty, staff, their children, and students who wish to pursue a BBA or EMBA degree under the MOU. Requirements



for the faculty scholarships include a bachelor's degree, English language skills equal to IELTS 5.0, access to a reliable internet connection, and ability to pay for non-tuition costs.

#### Duration


This MOU shall become effective upon signature by the authorized officials from LSi and Universidade Católica Timorese for a period of three years, and thereafter, automatically renew on an annual basis, unless either party provides a 30-day written notice of their intention to terminate the agreement. This agreement may be modified by mutual agreement.

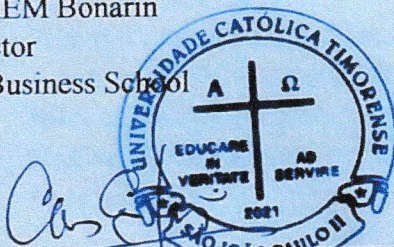
